

National Qualifications Framework

Ireland

- Student pays new "Student Contribution" replaces Registration Fee €3000
- Irish Government covers this if student qualifies for a student grant
- Student pays for a repeat Year

Scotland

- SAAS no plans to introduce fees for EU students in near future
- College fees paid by Scottish Executive for EU Nationals
- Fees paid via Student Awards Agency for Scotland directly to College
- No repayment of fees later

England

- Annual College Fees increased to: £6000 £9,250 for Degree Courses
- Fees published in each college website & under UCAS course search facility
- Payment by student may be deferred until after Graduation (loan from Student Loans Co.)

Northern Ireland & Wales

- Annual Fees currently £4,275 for degree courses and £2,500 for Foundation Degree courses.
- Payment by student may be deferred until after Graduation (loan from Student Loans Co.)

Student Loans

- Students resident in the EU for 3 years entitled to an interest free tuition fee loan from the Student Loan Company (www.slc.co.uk))
- Pay back when you start to earn £25,725 per year
- Payment amount rises annually with inflation
- Payment is 9% of your income above £25,725
- Debt wiped out 30 years after graduation

Repayment

If you lose your job repayments drop accordingly

If you earn £27,000 in a year, what do you repay?

The answer is £115, as £27,000 is £1,275 above the threshold and 9% of £1,275 is £115.

And if you earn £35,000, what do you repay?

The answer is £835. £35,000 is £9,275 above the threshold and 9% of that is £835.



Student Universal Support Ireland (SUSI)

Welcome to the SUSI website, a comprehensive source of information that provides you with a quick and user friendly way to apply for your student grant. Before applying for your grant however, we would encourage you to review the eligibility criteria by selecting your student type from the options below.

We would also encourage you to use our Eligibility Reckoner where you can quickly and easily self-assess whether you may be entitled to a grant. Links to the student grant legislation and a step-by-step guide to help with filling in an application can be found in our Resources page.

Will I be eligible for a maintenance grant?

To be eligible for a grant the

- student must be at least 17 years of **age** on the 1st January 2020 (in the case of PLC courses the student must be at least 16 years of age on commencement of the course).
- A student must have been ordinarily resident in the Republic of Ireland for three out of the last five years and must be an EU National. (Form S1 or proof of JC & LC from School)
- Parents must qualify under the **means test** applicable for the 2019 year.

Types of Maintenance Grants

Students studying in EU are eligible to apply for a Maintenance Grant.

- In ROI/EU students must be studying at Level 5 (PLC), or Level 6 (Higher Certificate), or Level 7 (Ordinary Degree), or Level 8 (Hons. Degree).
- In UK students must be studying at HND/Foundation Degree or above.
- The threshold rates & amount of grant are the same for each of the above Maintenance Grant types.

Original Documentation to be submitted with your Maintenance Grant Application Form.

• All Leaving Certificate candidates must provide documentary evidence of their residency for 3 out of the last 5 years.

- Photocopy Long Birth Certificate (not baptismal Cert)
- Documentary evidence of parents' permanent address e.g. ESB or phone bill with parent (s)/mature students name and address.

PAYE Income

• If parents are PAYE workers they should forward P60 & P21 for the tax year ended 31st December 2019. (A P21 can be obtained by sending P60 to the tax office and requesting same). A P45 if you have left employment during 2019.

Self -employed

• If parents are self employed they should submit set of accounts for the tax year ended between January — December 2019 and a Notice of Assessment for the same period.

Student Income

• Payment of applicant's income from employment.

Social Welfare Income

- If parents are in receipt of any social welfare payments they must submit a statement from their social welfare office stating the type and total amount of benefits received during the January December 2019 tax year.
- Please note that you **MUST** submit income details for the full 12 month period from January –December 2019. Therefore if parents are employed for part of the year and unemployed for the remainder they must submit a combination of the relevant documents.

Income from other Government Departments

• HSE, SOLAS, Teagasc, Youthreach, other

Retirement / Redundancy

- If you retired/were made redundant during the tax year, the following must be submitted:
 - Date employment ceased
 - Gross amount of lump sum
 - Number of years in that employment
 - Gross annual pension (retirement only)
 - P45 from employer stating details of lump sum.

Deposit Accounts

The interest element of Deposit accounts is regarded as reckonable income therefore interest certificates for 2019 must be supplied.

How does the Means Test work?

- To qualify for a grant you must satisfy a means test, that is, your income must be below a certain level.
- The following are the Reckonable Income Limits which apply for the current 2019/2020 academic year. (Rates reviewed annually)

No of Dependent Children	Full Maintenance and Full Student Contrbution	Part Maintenance (75%) and Full Student Contribution	Part Maintenance (50%) and Full Student Contribution	Part Maintenance (25%) and Full Student Contribution

The above limits may be increased by €4,830 if 2 children attending 3rd level.

Value of the Grant

- If your permanent address is 45 km (28 miles) or less from the Institute you are attending you will be eligible for the Adjacent Rate of funding.
- If you live over 45 km (28 miles) from the college you will be eligible for the full Non-adjacent Rate of grant.

What is the Special Rate Maintenance Grant?

• Parents' (FIS, Means tested one parent family payments, Carers allowance) for the 12 month tax year ended December 2019

Final Acceptance Form – FA1 Form

• When a student has received a definite course offer then they must complete their Final Acceptance form (online) together with their CAO/UCAS offer to the relevant authority to which they made their application.

Other points to Note

At present there is no funding available for the following:-

- Part-time and evening courses. Private colleges.
- Only Higher National Diploma/Foundation Degree courses are eligible for funding in Northern Ireland


